WE OPERATE A NATIONAL TOLL-FREE PEER SUPPORT CRISIS HOTLINE FOR TRANSGENDER PEOPLE. THE SERVICES PROVIDED ON THE HOTLINE INCLUDE RESOURCE REFERRAL, MENTAL HEALTH SERVICES IN THE FORM OF PEER COUNSELING AND SUICIDE PREVENTION. TRANSGENDER PEOPLE EXPERIENCE A SIGNIFICANTLY HIGHER RISK OF SUICIDE THAN THE GENERAL POPULATION (41% OF TRANSGENDER PEOPLE ATTEMPT SUICIDE AT SOME POINT IN THEIR LIFE). WE ARE THE ONLY CRISIS HOTLINE SPECIFICALLY TARGETING THE NEEDS OF THIS COMMUNITY. IN 2016, WE TRAINED 610 TRANSGENDER PEOPLE TO ANSWER CRISIS CALLS. OUR OPERATORS ANSWERED CALLS FROM 3,942 INDIVIDUALS AROUND THE COUNTRY IN 2016.
